Intermediate: 6-10 minutes; One or two pieces (or movements of one piece), that demonstrate contrasting character.

Senior: 10-15 minutes; two different pieces from two different time periods that demonstrate contrasting character.

* Student compositions will be allowed only if the student performs two other contrasting pieces from the standard published repertoire, within the allotted performance time.

* No chamber music transcriptions will be allowed.

* Please type or print clearly the program in order of performance. Please include complete composer's name, title, movement names, and opus numbers. Timing requirements will be strictly enforced.

* **Entrants must not repeat repertoire from prior year's CNYAMT competitions.**

Competition guidelines, please read carefully

- The competition will take place in a virtual format, with competition videos being submitted by YouTube link.
- Accompaniment is recommended, but not required. In the case of a tie, contestants using accompaniment will be given preference. If using, contestants must furnish their own accompanist.
- Contestants must digitally furnish one original solo part of all repertoire to the competition chairperson (Dana DiGennaro at danadigennaro@gmail.com) in a PDF format, sent along with the YouTube video link.
- Memorization is recommended but not required.
- In lieu of a winners' recital (this year only), winners' performance videos may be presented on our website, www.cnyamt.org.
- Monetary awards will be given, depending upon enrollment, up to a maximum of three places per division.
- Prior division winners will be required to move up to the next division regardless of age.
- The video performance of the competition program will be sent by YouTube link to the competition chairperson, Dana DiGennaro (danadigennaro@gmail.com). This link will show a full body video of the contestant playing their competition program. Each selection must be shown in one take, with no editing. The entrant may submit one video with all selections, or multiple videos of each selection separately. Please state your selection before you begin playing each one. **Do NOT state your name on the video, or have it included on the YouTube submission in any way, as this is an anonymous competition.** (Videos that include identifying material will be disqualified.)
- Two judges will assess each video entrant and may choose up to three winners in each division. The judges' decision is final.
- Competition final results will be given to teachers only, by e-mail or telephone within two weeks of the video deadline.
- Rules set forth on this page will be strictly enforced.
- Please refer any questions to the competition chairpersons.
